

Privacy Policy

This policy describes how **Geneoscopy** (“Geneoscopy” or “we”) collects, utilizes, and shares information from its websites, Geneoscopy.com and ColoSense.com (the “websites”). The websites are intended to provide visitors, potential investors and partners, and individuals who may be interested in working with us in the future to understand our technology and our company.

This policy concerns personal information that is gathered through the websites and does not describe our practices related to the collection of personal information – including health information – through any product or service that we may offer; that collection is described in a separate Notice of Privacy Practices that describes how we collect and use health information gathered in the course of the use any product or service that we may offer. No mobile information will be shared with third parties/affiliates for marketing/promotional purposes. All of the above categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties. This includes affiliate or business partners. The Opt-in is not transferable to another party involved in their process.

Cookie usage

Certain features on this websites use cookies to collect personal information about you, such as your name, email address, and other information that can be used to contact you. A cookie is a piece of data stored on a website visitor's hard drive to help us improve your access to our websites and identify repeat visitors. Cookies can also enable us to track and target the interests of our users to enhance the experience on our websites. You can set your browser to notify you when you receive a cookie, allowing you to decide whether to accept it. The usage of a cookie is in no way linked to any personally identifiable information on our site.

Our websites may place cookies in your browser. A cookie is a piece of data stored on a site visitor's computer through their browser to help us improve your access and identify repeat visitors to our websites. Cookies allow your browser to retain information about how you use a website so that the experience of future visits to the website can be enhanced. Cookies may remain on your computer for any length of time.

No sale of personal information

We do not sell personal information collected through the websites. We may transfer personal information in the circumstances noted below:

Third-Party Contractors – We may use contractors (“Service Providers”) to perform limited services on our behalf, such as hosting the websites and providing email services. Service Providers are required to obtain only the personal information they need to deliver the service

We reserve the right – in the event of a business transition such as a merger – to transfer personal information to a new business owner, on the condition that such personal information must be treated in accordance with this policy.

Compliance with Law and Prevention of Harm – We may disclose personal information or any information submitted via the websites if we have a good faith belief that disclosure of such information is helpful or reasonably necessary to: (i) comply with any applicable law, regulation, legal process or governmental request; (ii) enforce any applicable terms of service, including investigations of potential violations thereof; (iii) detect, prevent, or otherwise address fraud or security issues; or (iv) protect against harm to the rights, property or safety of our company, our users, yourself or the public. We may be required to disclose personal information in response to a lawful request by public authorities, including to meet national security or law enforcement requirements.

Security

We take generally accepted and industry-standard precautions to protect your information. However, no method of transmission over the Internet or method of electronic storage is entirely secure. Therefore, while we strive to use commercially reasonable means to protect personal information, we cannot guarantee its absolute security or confidentiality. Please be aware that certain personal information and other information provided by you in connection with your use of the websites may be stored on your device (even if that information is not collected by us). You are solely responsible for maintaining the security of your device from unauthorized access.
